Town Board Meeting Minutes – **APPROVED**

Date: Tuesday, June 17, 2025

1. Meeting called to order by Candahl at 5:00 p.m.
2. Minutes from 6/3/2025. Motion by Heal to approve minutes from 6/3/2025, second by Ehler. Motion carried unanimously.
3. Bills Payable. Motion by Ehler to pay open invoices for \$46,512.84, second by Heal. Heal asked about the easement payment to Lee and Kristen Baines. Peterson reminded the board they approved the agreement at an earlier meeting. Motion by Heal to accept closed invoices for \$43,372.31, second by Ehler. Motions carried unanimously.
4. Public Comment. The board received correspondence addressed to the board from Steve Peplinski (see attached).
5. Liquor and Tobacco Licenses. Ehler states the memo says Charlies Inn, and wanted to confirm it was approved as Wisco Johnnys. Motion by Heal, to approve the proposed list of Liquor and Tobacco Licenses for the period of July 1, 2025, to June 30, 2026, second by Ehler. Motion carried unanimously.
6. Fire Department Roof Quote. Peterson shared with the board a quote from Ledegar Roofing to replace roof 1 for \$24,000. Motion by Ehler to approve contingent on properly noticing the project, second by Heal. Motion carried unanimously.
7. ATV/UTV Plan. Peterson presented a current map and explained the process to approve ATV/UTV routes in La Crosse County. The board decides which routes to review, has a public hearing, then decides which routes to recommend approval to the county. After the county approves, it comes back to the town to approve an ordinance. No action taken at this time.
