1. Call to order at 4:30PM by Candahl

- 2. Motion by Ehler/Wichelt to approve the minutes of Nov. 24, 2014 and Dec. 15, 2014 Board Meetings with corrections. Motion carried.
- 3. Motion by Wichelt/Ehler to approve the payment of bills as presented \$103,268.79 and \$3,658,306.51 for January Tax Settlement to Schools, County, State, and tax overpayments to residents. Motion carried.
- 4. Board of Adjustment Appeals none currently
- 5. Citizens Comments:

Kopp: Requested copy of the Town Board meeting minutes to appoint the Clerk/Treasurer. These will be provided. Discussion on current Clerk and Treasurer positions and legal opinion on splitting. Option to possibly place on next Town Annual meeting for clarification.

Kopp: Requested the Town contact the State DOT to review the intersection of Knobloch and Hwy 33 since construction to request safety guard rails or concrete barricades due to the degree of drop off into the ravine. Temporary visual snow fencing or concrete barriers were also requested of the Town in the time being.

6. Discussion held on Budget adjustments for 2015.

Town Administrator wages for 2014 projected \$63,600. 2015 to \$64,500. Town Administrator benefits to show projected 2014 of \$22,000. 2015 changes to \$22,000 from \$31,000.

Town Admin. Deferred compensation projected 2014 \$8,000. 2015 \$8,000. Town Office Administration Total changes from \$397,000 to \$388,500, a reduction of \$8.500.

This equals a reduction in surplus from \$51,300 to \$42,800.

Motion by Ehler/Wichelt to approve 2015 Budget adjustments with a total reduction of \$8,500. Motion carried.

- 10. Motion by Ehler/Wichelt to sign Resolution 15-1 adopting the La Crosse County Multi-Hazard Mitigation Plan 2015-2019. Motion carried.
- 11. Motion by Wichelt/Candahl to approve definition of Town Board meetings that will be compensated as per the 12/15/14 Special Town Board meeting held. - 15. Admin Report: see attached report and 2015 Wage breakdown. Ehler and Brudos will meet with the La Crosse Water and Sewer Utility to seek renewal of contract. Proposal from Becher and Hoppe to conduct 2nd phase of study was approved.
- 16. Town Chair Candahl reported the Fire Dept. Chicken Q will be held on Sunday, March 15th. The Fire Dept. Game Feed will be held on Monday, Feb. 23rd. He will be meeting with the City Mayor and Dir. Public Works Hexom regarding SYB parking lot contract.
