The Town would like to thank all the residents for their patience while the Town continues to navigate the after effects of the storm in August. Work will continue into 2022 to repair road damage and our Administrator is working on a flood mitigation plan in hopes to minimize problems in the future.

PAYING PROPERTY TAX BILLS

Town Hall will be open from 8:00 a.m.– 4:00 p.m. Monday-Friday to accept payments for tax bills beginning December 8th. The Town Hall will be closed on December 24th and December 27th for the Christmas Holiday. The red drop box outside of Town Hall can be utilized 24/7. If you drop off or mail in your tax payment and would like a receipt, please also provide a self addressed, stamped envelope and a receipt will be mailed to you. Tax payments may take between 3-5 business days to be processed. Tax bills may be paid online, but please remember that fees and charges may apply for online payments at townofshelby.com.

PET LICENSES

Need to register your Pet? Bring your pet's most current rabies certificate and cash or check to complete the purchase of their license before January 1st. If not paid by April 1st, penalties are assessed by La Crosse County.

SCHEDULE HOUSE CHECK

Contact the Shelby Police Department or visit Town Hall to fill out a request form. The Police will drop by your house from time to time to make sure your home stays safe while you are traveling.

ABSENTEE BALLOTS

If you will be away from home and would still like to cast your ballot, please fill out a Absentee Ballot Application. Be sure you make your request allowing for mailing timeframes to receive and return the ballot. All ballots must be received by 8:00 p.m. on Election day to be counted. You will need to provide photo ID in order to receive a ballot per Wisconsin State Law.

REGISTER TO VOTE

If you need to register to vote, change your address or name, visit: myvote.wi.gov or visit Town Hall. State Law requires you be a town resident for 28 days prior to the election. You will need proof of address.

SNOW! SNOW! SNOW!

The Town Crew is ready for snow and has a few reminders to assist with the snow removal process as the drivers plow snow on the steep, narrow and curvy roads. We are asking residents to park in their driveways as often as possible. If it is necessary to park on the street, please do not park across from mailboxes or signs. In many cases this narrows the street, making it nearly impossible for the plow to get through. When it snows, the Road Crew will plow as early as possible to make sure the roads are open for your morning commute. If the snow is persistent, they will make a second trip with the plow. Keep this in mind when shoveling snow from your driveway. Plowing or pushing snow on the Town right-of-way is not allowed. If you plow snow across the road, you must have permission from the other land owner. Please remember to keep your refuse and recycling bins off the paved road and remove them from the road as soon as possible. Thank you!

Under state law (sec. 66.0602, Wis. Stats.), levy limits provide the maximum amount a town may implement as a property tax levy on parcels within their boundaries. In recent years, including 2021, the Town of Shelby tax levy was adopted at the maximum allowed. There are very few options to increase the tax levy limit, and unfortunately, inflation often outpaces these increases. Through careful planning, the proposed town budget for 2022 maintains the existing level of services and project funding. Although, in the future, it may be necessary to borrow funds or propose a referendum to increase the levy limit in order to cover expenses.
